

Absoft Corporation- NO FEE Run Time Redistribution License

IF YOU DESIRE TO DISTRIBUTE APPLICATIONS CREATED WITH AN ABSOFT COMPILER, SIGN AND RETURN THIS AGREEMENT. YOUR RIGHT TO DISTRIBUTE THE RUN TIME PORTION OF THIS SOFTWARE IS EFFECTIVE ONLY UPON ABSOFT'S RECEIPT OF A SIGNED COPY OF THIS AGREEMENT.

This agreement is entered into by and between Absoft Corporation, a Michigan corporation (Absoft) and the undersigned (Licensee).

RECITALS

Absoft has developed a certain runtime library used by their compilers and Licensee is a software developer and desires (i) to incorporate without modifications the object code for Absoft's run time library into its software (ii) to market or distribute the combined and resultant software product.

1. Definitions

(a) "Intellectual Property Rights" means all patents, patent rights, copyrights, copyright registrations, trade secrets, trademarks, service marks, trademark and service mark registrations, goodwill pertaining to trademark and service marks and confidential information.

(b) "Absoft Software" means the source code and object code for all computer programs and computer coded instructions for the Run Time Library; all related specifications, documentation, and technical information; and all corrections, modifications, additions, improvements, and enhancements to any of the foregoing.

2. Ownership. Absoft will own the Absoft Software and all copies of the Absoft Software and all Intellectual Property Rights in the Absoft Software. Whether or not any portion of the Absoft Software is or may be validly copyrighted or patented shall have no bearing on Absoft's Intellectual Property Rights. Except as set forth in this agreement, Absoft will have and retain the exclusive right to copy for distribution, market and distribute the Absoft Software, and any portions, corrections, modification, additions, improvements and enhancements of or to the Absoft Software that Absoft in its complete discretion may choose to develop, prepare, or market. Absoft may advertise, promote, market, sell, license, and distribute any of the foregoing or any similar software, in whole or in part, to any person anywhere in any manner, in the form delivered to Licensee or in any other form, without any obligation or liability to Licensee.

3. License. Absoft thereby grants to Licensee for the term of this agreement a nontransferable license, to use, market, and distribute the Absoft Software in unmodified object code form pursuant to the terms and conditions stated below. Any rights not expressly granted herein are expressly prohibited. Licensee shall have no rights in or to the source code for the Absoft Software.

(a) Right to distribute. Absoft grants to Licensee a non-exclusive, non transferable license during the term of this agreement and all renewal and extensions to incorporate the Absoft Software in software developed by Licensee and to use, replicate, manufacture, distribute, sell and sublicense the Absoft Software in unmodified object code form as incorporated in Licensee's software. Absoft Software must be linked in with Licensee's software or distributed as a DLL.

(b) Copy. Licensee shall have the non-exclusive right to copy the object code of the Absoft Software as necessary for the marketing or distribution of the Absoft Software as incorporated in Licensee's software as provided in this agreement.

(c) Restrictions on use of the Absoft Software. Except as otherwise provided herein, unless Absoft gives prior written consent, Licensee may not assign, license, or otherwise transfer voluntarily, whether by operation of law or otherwise, its right to use, market, or distribute the object code for the Absoft Software. Except as otherwise expressly permitted in this agreement, both before and after termination of this agreement for any reason, Licensee will refrain from:

(i) permitting any other person or entity to copy for distribution or to distribute all or any part of the Absoft Software; or

(ii) attempting, or permitting or encouraging any other person or entity to attempt, to tamper with, modify, reverse engineer, reverse compile, or disassemble the object code for the Absoft Software.

(d) Intellectual Property Rights notice. Licensee shall include the following Intellectual Property Rights notice somewhere in the documentation associated with the program, "Portions of this program include material copyrighted © by Absoft Corporation 1988-2018".

(e) Modifications and enhancements. Any and all modifications and enhancements made to the Absoft Software by Absoft or Licensee shall be the exclusive property of Absoft. Licensee shall have no rights whatever in or to any such modified or enhanced versions of the Absoft Software, except as expressly provided in this agreement. Nothing in this agreement shall require Absoft to make any modifications or enhancements to the Absoft Software.

4. DISCLAIMER OF WARRANTIES. LICENSEE AGREES THAT ABSOFT MAKES NO WARRANTIES WHATEVER, EXPRESS OR IMPLIED, WITH REGARD TO THE SERVICES PROVIDED UNDER THIS AGREEMENT OR THE ABSOFT SOFTWARE OR ANY OF ITS PARTS, AND THAT ABSOFT EXPRESSLY DISCLAIMS ALL WARRANTIES OF MERCHANT ABILITY AND FITNESS FOR A PARTICULAR PURPOSE. ABSOFT EXPRESSLY DOES NOT WARRANT THAT THE ABSOFT SOFTWARE OR ANY OF ITS PARTS WILL BE ERROR FREE.

5. LIMITATION OF LIABILITY. ABSOFT WILL NOT BE LIABLE FOR ANY SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES, EVEN IF INFORMED OF THE POSSIBILITY OF SUCH DAMAGES IN ADVANCE. THESE LIMITATIONS APPLY TO ALL CAUSES OF ACTION IN THE AGGREGATE, WARRANTY, ABSOFT'S NEGLIGENCE, STRICT LIABILITY, MISREPRESENTATION, AND OTHER TORTS.

6. Term and Termination. This agreement will continue in full force and effect for an indefinite term except that Absoft will have the right to terminate this agreement if Licensee breaches or fails to perform any term or condition of this agreement.
